The specific roadwork and **other public improvements** covered by this Letter are as set forth on said series of maps, the East Haddam Subdivision Regulations as in force on the date of approval, and the East Haddam Road Specifications referenced therein.

Upon receipt of that notice, you shall have the right to draw against the amount remaining available under this Letter of Credit in accordance with terms of this Letter of Credit and accompanied by the beneficiary's statement signed by the said First Selectman or his designee, stating:

We here waive the right to defer the honor of any such drafts presented by the beneficiary or by any drawer, endorser, or bona fide holder of any such drafts.
